The OLEV (Office for Low Emission Vehicles) Workplace Charging Scheme (WCS) allows businesses and organisations across the UK to benefit from grant funding towards the purchase and installation of EV charging points.

A total of £350 per socket is available, with businesses and organisations able to adopt up to a maximum of 40 sockets. Businesses and organisations are therefore entitled to up to £14,000 of OLEV grant funding for their workplace.

CLAIM YOUR WCS OLEV GRANT & INSTALLATION PROCEDURE

- 1 Your workplace registers its intention to have an EV charging point installed by visiting the following link:
www.apply-workplace-chargepoint-grant.service.gov.uk
- 2 Once the application has been completed and sent, OLEV will review it and inform you by email (usually within 5-7 working days) whether the application has been successful, or whether they require further information.
- 3 If the application is successful, you will be issued with a voucher/ vouchers to the value of the application (£350 for a 1way EV charging unit, or £700 for a 2way charging unit. Up to a maximum of £14,000 per workplace).
- 4 Once you have your vouchers, get in touch with us: 01205 724754 / rolec@rolecserv.co.uk, we will then source a WCS OLEV/Rolec Approved Installer who will provide you with a full site survey and commence installation when required.
- 5 On completion of the installation hand over the WCS voucher to the installer, who will then claim the value back from OLEV.

Conditions of Eligibility:

- Your business must have sufficient off-street parking.
- You must have the EV charging units installed by an OLEV/Rolec Approved WCS Installer.
- WCS vouchers are valid for 120 days from the date of issue.
- You cannot retrospectively claim for existing charging points at your business premises.
